

LOAN CONTRACT TERMS

Version NZ-S2-2025-1

1. **Loan Contract:** The terms and conditions of your Loan Contract are set out in your Loan Disclosure Statement, together with the Vehicle Details Form (if applicable), and this Loan Contract Terms document. Your Loan Disclosure Statement prevails over this Loan Contract Terms document to the extent of any inconsistency.
2. **Effective date:** Your Loan Contract comes into effect if, after you have been provided with your Loan Contract, you accept or confirm that you want to continue.
3. **Borrower:** The Borrower under your Loan Contract is specified in your Loan Disclosure Statement. If more than one person is the Borrower:
 - (a) you are jointly and individually liable under your Loan Contract;
 - (b) we can accept instructions from any of you (without reference to any other person who is the Borrower) in respect of your Loan Contract; and
 - (c) each of you can agree on behalf of all of you to changes to your Loan Contract.
4. **Participating Investors:** Any Participating Investors are anonymous to the Borrower, and you will not receive information about them. No Participating Investor is a party to your Loan Contract.
5. **Agreement to lend:** Your Loan will be lent to you on and subject to the terms of your Loan Contract.
6. **Secured Loans**
 - (a) A Secured Loan may be available where you wish to use the Loan for the purchase of a vehicle. If so, the interest rates for Secured Loans (and unsecured loans) will be presented to you when you apply for your Loan.
 - (b) If you take out a Secured Loan, you must:
 - (i) purchase a Vehicle within 60 days of the Date of Advance; and
 - (ii) satisfy the Secured Loan Conditions immediately upon purchasing the Vehicle.
 - (c) If you do not satisfy clause 6(b) above, at the end of the 60-day period referred to in clause 6(b)(i):

- (i) the interest rate applicable to your Loan will change to the annual unsecured interest rate (as set out in your Loan Disclosure Statement); and
- (ii) the required payments under your Loan will change.

We will notify you of the consequential changes to your payment schedule.

7. Security Interest

- (a) Any security interest created under your Loan Contract continues at all times and applies to all present and future amounts you owe at any time to Harmoney Lender (including future advances for the purposes of sections 71 and 72 of the PPSA).
- (b) This security interest remains in full force until you have fully repaid all the money you owe Harmoney Lender, and Harmoney Lender releases you from the security interest. If you want to sell the Vehicle or you have repaid all the money you owe to Harmoney Lender, you can request a release from Harmoney Lender.
- (c) In addition to this document, the Loan Disclosure Statement contains terms and conditions which apply to a Secured Loan.

8. Insurance

- (a) You must renew and maintain the Insurance Policy throughout the term of the Loan, and at all times pay all insurance premiums under the insurance policy on time. Upon request by Harmoney Lender, you must provide Harmoney Lender with a copy of the current Insurance Policy and premium receipts.
- (b) You must not do anything which would lead to the Insurance Policy being cancelled or adversely affected. Upon request by Harmoney Lender, you must provide Harmoney Lender with a certificate from your insurer showing this clause is being complied with.
- (c) Any money you are entitled to under any insurance on the Vehicle is to be applied, at the option of Harmoney Lender, either in or towards rebuilding, repairing or replacing the Vehicle or meeting the liability insured against or in reduction of the amount you owe Harmoney Lender.

9. Verification statement

You waive your right under section 148 of the PPSA to receive a copy of a verification statement in respect of any financing statement or financing change statement registered by Harmoney Lender in respect of any secured property.

10. Vehicle maintenance and compliance

- (a) You must:
 - (i) comply with all legislation or other requirements affecting your possession and use of the Vehicle, including obtaining and

keeping current all necessary registrations and licences relating to your possession or use of the Vehicle;

- (ii) immediately notify Harmony Lender of any change of identifying detail of the Vehicle (such as chassis or registration number);
 - (iii) immediately notify Harmony Lender in writing if you lose possession of the Vehicle (e.g. if it is stolen, lost, taken from you under a court order, destroyed or written off), and, if known, advise Harmony Lender of the Vehicle's location;
 - (iv) upon request by Harmony Lender, deposit all documents of title constituting or evidencing ownership of the Vehicle;
 - (v) promptly do everything reasonably requested by Harmony Lender to preserve and protect the value of the Vehicle and protect and enforce Harmony Lender's title and rights to the Vehicle; and
 - (vi) give Harmony Lender 30 days prior notice if you intend to change your name.
- (b) You must not, without Harmony Lender's prior written consent:
- (i) sell, lease, exchange, trade-in or otherwise dispose of the Vehicle;
 - (ii) grant any security interest over the Vehicle (other than to Harmony Lender) or give anyone else rights in the Vehicle;
 - (iii) remove the Vehicle from New Zealand;
 - (iv) do anything which may cause or contribute to the deterioration in value of the Vehicle; or
 - (v) do, or fail to do, anything which could adversely affect Harmony Lender's security interest in the Vehicle.

11. **Date of Advance:** The loan amount (specified in your Loan Disclosure Statement) is lent to you by Harmony Lender on the Date of Advance. We may pay any part of the Loan to a third party in accordance with your instructions. In the unlikely event that the Date of Advance does not occur within 14 days of the Loan Contract coming into effect, then your Loan Contract will automatically be cancelled. If this happens, Harmony Servicer will notify you of that fact.

12. **Interest:** Interest is charged and payable monthly in arrears as part of your required payments (as specified in your Loan Disclosure Statement).

13. **Required Payments:** You must pay to Harmony Lender as and when due all required payments specified in your Loan Disclosure Statement, which comprise principal and interest. Each required payment will be direct debited from your Nominated Account on the date it is due (unless otherwise agreed). You may select a direct debit start date and frequency that suits you, provided that each required

payment is paid in full by its due date. For the avoidance of doubt (and without limiting any other payment obligation under your Loan Contract) you must pay Harmoney Lender back in full the Loan together with all interest, fees, charges and other amounts payable by you under your Loan Contract, and no such amount may be outstanding after the final due date for a required payment specified in your Loan Disclosure Statement.

14. **Fees and Charges:** You must pay to Harmoney Lender all fees and charges (including default fees and charges) referred to in your Loan Disclosure Statement and in the Fees and Charges section set out below. Any such fees and charges will be direct debited from your Nominated Account on the date they are due (unless paid from, and forming part of, your Loan on the Date of Advance or otherwise agreed).
15. **Early Repayment Option:** You can prepay to Harmoney Lender your Loan or any portion of it early. If you choose to prepay the entire Loan, you must pay to Harmoney Lender the full outstanding amount of your Loan together with all interest, fees, charges and other amounts payable by you under your Loan Contract and accrued to the date of prepayment. If you choose at any time to make direct debit payments more frequently than the due date each month:
 - (a) these are prepayments under this clause, which means that there is no formal variation to your required monthly payments and you can choose to change your direct debit frequency again at any time (provided that each required payment is paid in full by its due date); and
 - (b) like any prepayment, the total amount of the interest charges payable under your Loan Contract (and therefore the total amount of payments) may be less, because these prepayments reduce the unpaid balance of your Loan earlier each month.
16. **Payment Provisions:**
 - (a) You must make every payment under your Loan Contract:
 - (i) as and when due;
 - (ii) without set-off;
 - (iii) in cleared funds and in full, without any deduction or withholding, except as may be required by law; and
 - (iv) to the Collections Account.
 - (b) Unless we have agreed with you otherwise, Harmoney Servicer will decide the order in which amounts we receive in connection with this Loan Contract (or any other loan agreement(s) you have entered into with us) will be applied to this Loan Contract (or any other loan agreement(s) you have entered into with us).
 - (c) You agree to a direct debit authority being established and maintained against your Nominated Account, on the Direct Debit Terms set out below, in relation to the amounts payable by you to Harmoney Lender under your Loan Contract. You may change your direct debit frequency at any time, provided that each required payment specified in your Loan Disclosure

Statement is paid in full by its due date. You must ensure that your Nominated Account has sufficient funds at all relevant times to honour each direct debit payment. If any direct debit payment will not be made or honoured for any reason, you must make alternative arrangements to ensure that each required payment is made in full by its due date in accordance with these payment provisions.

- (d) If any amount payable by you under your Loan Contract is not paid when due in accordance with this document, that amount will continue to constitute a debt due by you to Harmony Lender until it is paid in full (see also clause 19 below).
- (e) You agree to waive any right of set-off you may have against Harmony Lender or Harmony Servicer.

17. **Tax Matters:**

- (a) You will not be required to withhold or account to Inland Revenue for any RWT in relation to interest payments you make under your Loan. This is because Harmony Lender holds an RWT Exemption Certificate.
- (b) In certain circumstances where a Participating Investor is not resident in New Zealand for income tax purposes, you may be required to:
 - (i) withhold and account to Inland Revenue for NRWT; or
 - (ii) pay AIL to Inland Revenue, in relation to interest payments you make under your Loan.
- (c) Harmony Lender will meet all NRWT or AIL obligations on your behalf from the payments you make under your Loan Contract, immediately upon payment of the relevant interest into the Collections Account. For this purpose, you:
 - (i) authorise Harmony Lender to act on your behalf and to do all things necessary (including, where required, completing Inland Revenue registration forms and providing all necessary information about you to Inland Revenue) to meet any NRWT or AIL obligations on your interest payments; and
 - (ii) agree to provide Harmony Lender with all necessary information (including your IRD number and any other relevant personal or tax-related information) for it to act effectively for the purposes described above.
- (d) You are not required to make any additional payment as a top-up for the NRWT or AIL deduction. To the extent allowable, Harmony Lender will also undertake any required investment income reporting on your behalf.

18. **Warranties:** You warrant to us that:

- (a) all information you provide to us is true, accurate, and complete, and there is no information which has not been provided which would impact on a decision to register you as a Borrower or to make a Loan available;

- (b) you will provide us with updated information if any of your circumstances have changed;
- (c) if your contact details change, you will immediately provide us with details of the change and update the dashboard with your revised information;
- (d) where you have undertaken, confirmed or represented in the course of making your loan application that you will take any action or step (including but not limited to closing a credit account or other facility), you will perform that action or step promptly; and
- (e) if you grant us a security interest over a Vehicle, you own the Vehicle free of other security interests and there are no undisclosed security interests over the Vehicle.

19. **Default:**

- (a) If you:
 - (i) breach any term of this Loan Contract;
 - (ii) do not pay any money due under your Loan Contract on the due date;
 - (iii) commit an act of bankruptcy (as defined in the Insolvency Act 2006); or
 - (iv) provided us with incorrect or fraudulent information,

we may take any of the steps described in clause 19(b) below.
- (b) We, or any receiver, may:
 - (i) by notice to you, declare all money outstanding under your Loan Contract (including all accrued interest, fees, charges and other amounts payable by you under your Loan Contract) immediately due and payable. In that case, you must immediately pay that outstanding money to Harmoney Lender;
 - (ii) exercise any collection, enforcement or other rights available to us which may include taking appropriate recovery action (such as appointing a collection agent, instituting legal proceedings, or selling your Loan Contract to another person) and you must promptly and fully comply with all requests and directions we give you when we exercise these rights; and
 - (iii) where you have entered into a Secured Loan:
 - (a) immediately enforce our security interest in the Vehicle, take possession of the Vehicle, sell the Vehicle, and use the proceeds to repay the Loan;
 - (b) appoint any person or persons to be a receiver of the Vehicle (and without limiting or affecting, any other

powers and authorities conferred on a receiver) the receiver has the power to do all things in relation to the Vehicle as if the receiver had absolute ownership of the Vehicle;

(c) exercise all other rights conferred to Harmony Lender by law (including under Part 9 of the PPSA) in relation to the Vehicle; and

(d) in relation to a Vehicle:

(i) sell all or any part of the Vehicle;

(ii) cancel an agreement for sale over the Vehicle, and in that event, re-sell the relevant property without being answerable for any reduction in price; or

(iii) exercise any other incidental rights in connection with the sale (whether under this Loan Contract or by law, agreement or otherwise).

(c) If Harmony Lender or a receiver intends to exercise a right to sell the Vehicle, you must not do anything to delay, adversely affect or otherwise prevent a prompt sale of the Vehicle and transfer to the purchaser.

(d) This Loan Contract may be enforced regardless of whether Harmony Lender has accepted a payment from you after the Default has occurred and without having to give notice to you or seek your consent. Harmony Lender and any receiver is not responsible for any loss, or for any act or thing done or omitted, and is not obliged to enforce any right under any agreement for sale.

(e) In the event of a breach of your Loan Contract or on the enforcement of your Loan Contract, you must also pay to Harmony Lender any applicable default fees and charges referred to in your Loan Disclosure Statement. Any such fees and charges will be direct debited from your Nominated Account on the date they are due (unless otherwise agreed).

20. **Limitation of Liability**

(a) If Harmony Lender (referred to in this clause as the **Trustee**) has entered into your Loan Contract as bare trustee for Participating Investors, the Trustee holds all rights and powers vested in it under or in connection with your Loan Contract as bare trustee for the Participating Investors in accordance with their respective interests, on and subject to the terms of the Trustee's appointment.

(b) Without limiting the above clause (a), no Relevant Person will be liable if it fails to comply with your Loan Contract due to events beyond its reasonable control (including due to any Participating Investors failing to fund your Loan). Nothing in this clause (b) or your Loan Contract limits any rights you may have at law.

21. **Changes to Terms**

- (a) You authorise us to correct any minor errors in your Loan Contract (including inserting dates and Loan references), the amendment of which would not have a material effect on the Loan Contract.
- (b) Subject to any applicable law, we may change any terms of your Loan Contract without your consent for one or more of the following reasons:
 - (i) to reduce your obligations under your Loan Contract (including by reducing the interest rate of your Loan), or to add benefits or new features to your Loan and/or other products;
 - (ii) to comply with any change or anticipated changes in any relevant law, code of practice or guidance, or to reflect any decision of a court, ombudsman or regulator;
 - (iii) to reflect a change in our systems, procedures or circumstances (including for security reasons); or
 - (iv) to make the terms of your Loan Contract clearer.
- (c) We may introduce a new type of fee under your Loan Contract, or amend any fee payable under your Loan Contract, but only in accordance with applicable law (including applicable lender responsibility principles and notice requirements) and only if (acting reasonably) we consider the introduction or amendment to be necessary or appropriate in all the circumstances. Harmony Servicer will be entitled to process additional debit payments to cover any such fees.
- (d) Subject to the above clauses (a) through (c), we will not otherwise, without your prior agreement, amend the interest rate applying to your Loan, the loan term, the loan amount, the amounts of any loan repayments, the loan repayment dates, or any other matter, except as expressly permitted in your Loan Contract.

22. **Notices**

- (a) You must provide all notices to us in writing (including by email) using the contact details provided in your Loan Disclosure Statement or any updated details provided by Harmony Servicer or on the Website at the relevant time.
- (b) You consent to receiving all notices, documents and communications relating to your Loan (including ongoing disclosure information required by law) in electronic form and by electronic means, including to any electronic message address specified by you, or through the Website (including the dashboard).

23. **Records:** If your records and ours disagree regarding the effective date of the Loan Contract, the Date of Advance, or the date of any payment or system processing, our records will prevail in the absence of any evidence to the contrary.

24. **Severability:** The illegality, invalidity or unenforceability of any provision in your Loan Contract will not affect the legality, validity or enforceability of another provision.

25. **Privity:** Each of Harmoney Lender and Harmoney Servicer can enforce its rights under your Loan Contract even if it has not signed your Loan Contract.

26. **Assignment:**

(a) You may not transfer or assign any of your rights or obligations under your Loan Contract to any person.

(b) Each of Harmoney Lender and Harmoney Servicer may transfer or assign all and any of its rights and/or obligations under your Loan Contract to any person, without requiring your consent.

27. **Governing Law:** Your Loan Contract is governed by New Zealand law. The parties submit to the non-exclusive jurisdiction of the New Zealand courts in respect of all matters relating to your Loan Contract and your Loan.

28. **Definitions:** In your Loan Contract, terms defined in your Loan Disclosure Statement have the same meanings where used in this document and:

AIL means approved issuer levy payable under part 6B of the Stamp and Cheque Duties Act 1971;

Borrower means the person(s) specified as the borrower in your Loan Disclosure Statement;

Business Day means a day other than a Saturday, Sunday, or statutory public holiday in New Zealand;

Collections Account means the Harmoney Lender bank account into which (among other things) payments of principal and interest and other amounts payable by you under your Loan Contract must be paid;

Date of Advance has the meaning given to that term in your Loan Disclosure Statement;

Harmoney Lender has the meaning given to that term in your Loan Disclosure Statement;

Harmoney Servicer has the meaning given to that term in your Loan Disclosure Statement;

Insurance Policy means the insurance policy over the Vehicle for which you provide Harmoney Lender with a certificate of insurance in accordance with the Loan Disclosure Statement (in the section titled "Secured Loan Conditions");

Loan means the total amount lent or to be lent by Harmoney Lender to you under your Loan Contract (whether credited to your bank account or otherwise applied for your benefit);

Loan Contract means the agreement between you and us in respect of your Loan, which comprises your Loan Disclosure Statement, the Vehicle Details Form (if applicable), and this Loan Contract Terms document;

Loan Disclosure Statement means the loan disclosure statement provided to you in respect of your Loan;

Nominated Account means the New Zealand bank account which is nominated by the Borrower from time to time as the account into which Loan advances are to be paid and from which amounts payable to Harmony Lender are to be direct debited;

NRWT means non-resident withholding tax imposed under the NRWT rules in the Income Tax Act 2007;

Participating Investor in relation to your Loan means (if applicable) each investor for whom Harmony Lender as bare trustee holds your Loan;

PPSA means the Personal Property Securities Act 1999;

financing statement, financing change statement, future advance, secured party, secured property, and verification statement have the meanings given to them in, or in the context of, the PPSA;

Proceeds means all money received directly or indirectly by you from the Vehicle (e.g. if you sell, rent out or trade the Vehicle);

Relevant Person means any of Harmony Lender, Harmony Servicer or any related company (as defined in section 2(3) of the Companies Act 1993) of those entities, and any employee, director, officer, agent, and contractor of those entities or such related company;

RWT means resident withholding tax imposed under the RWT rules in the Income Tax Act 2007;

RWT Exemption Certificate has the meaning given in section YA 1 of the Income Tax Act 2007;

Secured Loan means a Loan for which the proceeds are to be used towards the purchase of a vehicle for which a security interest is to be granted to Harmony Lender;

Secured Loan Conditions means each of the conditions set out in your Loan Disclosure Statement that apply to a Secured Loan;

Vehicle means all present and future right, title and interest (legal and equitable) in, all documents of title relating to, and all Proceeds of the specific vehicle to which this Loan Contract relates;

Vehicle Details Form means (in relation to a Secured Loan only) the form to be delivered in relation to a purchased vehicle containing the information set out in that form; and

Website means the website at www.harmony.co.nz, or such other website as Harmony Servicer or a Relevant Person may from time to time operate.

29. **Interpretation:** In your Loan Contract:

- (a) headings are inserted for ease of reference only, and do not affect the interpretation of your Loan Contract;
- (b) references to you or your means the Borrower;
- (c) references to the singular include the plural, and vice versa;
- (d) references to a person include an individual, company, corporation, partnership, firm, joint venture, association, trust, unincorporated body of persons, governmental or other regulatory body, authority or entity, in each case whether or not having a separate legal identity;
- (e) references to any party (including Harmony Lender and Harmony Servicer) includes any permitted assignee or transferee; and any reference to Harmony Servicer includes any back up servicer entity appointed to replace it;
- (f) references to the liability of a person include references to its liability under any cause of action, whether in contract, tort, or equity or under any enactment;
- (g) references to any document (however described) are references to that document as modified, novated, supplemented, varied or replaced from time to time and in any form, whether on paper or in an electronic form; and
- (h) a reference to any legislation is a reference to that legislation as amended or replaced from time to time, and includes any regulations or legislative instrument made under it.

DIRECT DEBIT TERMS

In these terms, references to "Initiator" are references to Harmony Servicer (or its successors or assigns) and references to the "Customer" are references to the Borrower.

Conditions of instruction to accept direct debits

1. The Initiator:
 - 1.1. Will provide notice either:
 - (a) in writing; or
 - (b) by electronic mail where the Customer has provided prior written consent to the Initiator.
 - 1.2. Has agreed to give advance Notice of the net amount of each Direct Debit and the due date of the debiting at least 10 calendar days (but not more than 2 calendar months) before the date when the Direct Debit will be initiated.
 - 1.3. The advance notice will include the following message:

“Unless advice to the contrary is received from you by (date*), the amount of \$..... will be directly debited to your Bank account on (initiating date*).”

*This date will be at least two (2) days prior to the initiating date to allow for amendment of Direct Debits.
 - 1.4. Alternatively, the Initiator undertakes to give notice to the Acceptor of the commencement date, frequency and amount at least 10 calendar days before the first Direct Debit is drawn (but no more than 2 calendar months).
 - 1.5. Where the Direct Debit System is used for the collection of payments which are regular as to frequency, but variable as to amounts, the Initiator undertakes to provide the Acceptor with a schedule detailing each payment amount and each payment date.
 - 1.6. In the event of any subsequent change to the frequency or amount of the Direct Debits, the Initiator has agreed to give advance notice of at least 30 days before the change comes into effect. This notice must be provided either:
 - (a) in writing; or
 - (b) by electronic mail where the Customer has provided prior written consent to the Initiator.
 - 1.7. May initiate a Direct Debit on my/our account when authorisation is received from me/us in accordance with the terms and conditions agreed between me/us and the Initiator of each amount to be debited from my/our account.
 - 1.8. Notice will be sent of the net amount of each Direct Debit and the due date of debiting after receiving authorisation from me/us under clause 1.7 but no later than the date the Direct Debit will be initiated. This notice must be provided either:
 - (a) in writing; or
 - (b) by any other means which provides a verifiable record of the initiated transaction and where the Customer has provided prior written consent to the Initiator.

- 1.9. Where the notice is in writing it must include the following message:
- “The amount \$..... was directly debited to your Bank account on (initiating date).”
- 1.10. Where the notice is provided by other means:
- (a) the Initiator should hold prior written consent of those means of providing notice; and
 - (b) the notice should provide a verifiable record of the initiated transaction and include the amount and initiating date of that transaction.
- 1.11. May, upon the relationship which gave rise to this Instruction being terminated, give notice to the Bank that no further Direct Debits are to be initiated under the Instruction. Upon receipt of such notice the Bank may terminate this Instruction as to future payments by notice in writing to me/us.
2. The Customer may:
- 2.1. At any time, terminate this Instruction as to future payments by giving written (or by the means previously agreed in writing) notice of termination to the Bank and to the Initiator.
- 2.2. Stop payment of any Direct Debit to be initiated under this Instruction by the Initiator by giving written notice to the Bank prior to the Direct Debit being paid by the Bank.
- 2.3. Where no advance notice is provided under clause 1.7 a variation to the amount agreed between the Initiator and the Customer from time to time to be Direct Debited had been made without notice being given in terms of clause 1.7 above, request the Bank to reverse or alter any such Direct Debit initiated by the Initiator by debiting the amount of the reversal or alteration of Direct Debit back to the Initiator through the Initiator's Bank PROVIDED such request is made not more than 120 days from the date when the Direct Debit was debited to my/our account.
- 2.4. Request the Bank to reverse any Direct Debits initiated by the Initiator under the Instructions by debiting the amount of the Direct Debits back to the Initiator through the Initiator's Bank where the Initiator cannot produce a copy of the Instructions and/or Confirmation to me/us that I/we are reasonably satisfied demonstrate that I/we have authorised my/our bank to accept Direct Debits from the Initiator against my/our account PROVIDED the request is made not more than 9 months from the date when the first Direct Debit was debited to my/our account by the Initiator under the Instructions.
3. The Customer acknowledges that:
- 3.1. This Instruction will remain in full force and effect in respect of all Direct Debits passed to my/our account in good faith notwithstanding my/our death, bankruptcy or other revocation of this Instruction until actual notice of such event is received by the Bank.
- 3.2. In any event this Instruction is subject to any arrangement now or hereafter existing between me/us and the Bank in relation to my/our account.
- 3.3. Any dispute as to the correctness or validity of an amount debited to my/our account shall not be the concern of the Bank except in so far as the Direct Debit has not been paid in accordance with this Instruction. Any other disputes lie between me/us and the Initiator.
- 3.4. Where the Bank has used reasonable care and skill in acting in accordance with this Instruction, the Bank accepts no responsibility or liability in respect of:

- (a) the accuracy of information about Direct Debits on Bank statements; and
 - (b) any variations between notices given by the Initiator and the amounts of Direct Debits.
- 3.5. The Bank is not responsible for, or under any liability in respect of the Initiator's failure to give notice in accordance with clauses 1.1 to 1.7, nor for the non-receipt or late receipt of notice by me/us for any reason whatsoever. In any such situation the dispute lies between me/us and the Initiator.
- 3.6. Where notice given by the Initiator in terms of clause 1.7 to the debtor responsible for the payment shall be effective. Any communication necessary because the debtor responsible for payment is a person other than me/us is a matter between me/us and the debtor concerned.
- 4. The Bank may:
 - 4.1. In its absolute discretion conclusively determine the order of priority of payment by it of any monies pursuant to this or any other Instruction, cheque or draft properly signed by me/us and given to or drawn on the Bank.
 - 4.2. At any time terminate this Instruction as to future payments by notice in writing to me/us.
 - 4.3. Charge its current fees for this service in force from time to time.

FEES AND CHARGES

Borrowers will be charged no additional fees beyond the one-off establishment fee, except in the event of a breach of the loan contract or on the enforcement of the loan contract.

Please note that fees and charges can be varied in accordance with the applicable loan contract.

Establishment fee

Borrowers are charged an up-front, one-off establishment fee for approved loans.

The establishment fee covers the arranging costs incurred in connection with the loan application, including the processing and consideration of that application, documenting the loan, and administration around advancing the loan.

The establishment fee is paid from the Borrower's loan on the date the loan is advanced. The amount of the fee is added to the approved loan amount and forms part of the principal amount of the loan (which is repaid, together with interest, by regular payments as specified in the loan contract).

These establishment fees also apply to Top Ups.

Dishonour fee

In the case where a Borrower's payment is dishonoured, a \$15 fee may be charged. However, you will not be charged this fee if a direct debit payment for weekly or fortnightly payments is dishonoured, as long as you still pay your required monthly payment in full by the due date each month.

The dishonour fee covers the costs of the additional administration required to re-process and arrange the payment as part of the collection process.

Any dishonour fee will be charged to the Borrower and direct debited from the Borrower's nominated bank account on the Borrower's next payment due date.

Overdue fee

The overdue fee is charged if a payment is not made in full when due and the account goes into arrears. The fee payable is \$20 on each of 6, 36, 66, 96 and 120 days after the payment due date, if the account remains in arrears.

The overdue fee covers the costs of the additional administration required to manage the collection process for an overdue account, which includes arranging for a collection process in respect of the arrears amount, updating and maintaining records, and other necessary and incidental services to the collection process.

The overdue fee is charged to the Borrower and direct debited from the Borrower's nominated bank account on the Borrower's next payment due date.

Collection and enforcement fees

If collection or enforcement action is required against a Borrower, an amount that is no more than the legal and associated third party costs or expenses incurred in that collection or enforcement process (if any) will be charged to the Borrower.

These fees cover the costs or expenses incurred when a third party is instructed to assist with recovery in respect of an overdue account.

These fees are charged to the Borrower and direct debited from the Borrower's nominated bank account on the Borrower's next payment due date.
